MEMBERS MUSINGS



AT WHAT POINT?

At what point do new-comers "catch-on" to our program? When does AA begin to work for any of us? And, even more importantly, how do we stop being a person with problems and become the person with a solution?

These questions came to me today... during my morning Eleventh Step. My first thought was that we are afflicted with a three-fold illness... mental, physical & spiritual. Next came a passage from the Big Book, "When the spiritual malady is overcome, we straighten out mentally & physically." Then I reviewed my personal experience.

In early sobriety I had mistakenly thought the first

thing I experienced was God freeing me from my mental obsession to drink. In other words, God straightened me out mentally... ahead of correcting my spiritual malady. But I was in for a surprise. My spiritual malady was indeed overcome first, only through the Grace of God, because surrender and conscious contact with God came first ... and at that point He removed my mental obsession to drink.

My early mistake was then compounded when I thought, "Well, now that I am sober, everything will be wonderful!" But it wasn't...and, to this day, everything is not always wonderful.

"How can this be?", I wondered. "Why is it that, all too often, I'm restless, irritable & discontented?" I pondered these questions during a morning Eleventh Step until, as if thunderstruck, it came to me. To be a person who lives in the solution means that when I have a problem I see it as an opportunity to

practice the program of Alcoholics Anonymous. Problems are no longer problems...they are opportunities.

I realized my alcoholism can flare-up at any moment and that I must expect outbreaks & be aware of them. The next step was simple. I'm told what to do in Step Ten. "Continue to watch for selfishness, dishonesty, resentment and fear. When these crop up, we ask God at once to remove them. We discuss them with someone immediately and make amends quickly if we have harmed anyone. Then we resolutely turn our thoughts to someone we can help."

And it works like magic. In that early experience I saw that selfish fear of being restless, irritable, and discontented was a problem. And, as soon as I asked God to remove the selfish fear, He did.

I then discussed this miracle with an AA friend and while doing so we both thought of someone this discovery could help.

In Step Eleven I'm told that, "We alcoholics are undisciplined. So we let God discipline us in the simple way we have just outlined." This does not give me permission to be undisciplined, it tells me I must grow up. It tells me I must become a mature, sensible, responsible, and disciplined person who practices the program of Alcoholics Anonymous instead of behaving like a selfish and childish brat.

An old-timer from Miami says, "Step Eleven is the powerhouse of AA". It's true. It was a morning Eleventh Step, (many mornings ago) that led me to living in the solution rather than in the problem.

So, at what point can newcomers, or anyone else for that matter, learn to get out their problems and live in the solution? At any point you like.

When I sense a need for God's help, I take this opportunity to ask Him for a miracle. I simply ask Him to let me perceive problems as opportunities

and, as Dr Bob has told us, "Your Heavenly Father will never let you down!"

My name is George, I'm an alcoholic. I've been writing about thoughts like this ever since the death of my good friend Douglas. I can no longer discuss these topics with him. I miss him.

TRAVELING HIGHLIGHTS



AA in San Diego

In January of this year my husband and I were offered the use of our son's condominium in San Diego, California, for the month of January.

I had spent two days there in 2005 on my Grandson's first birthday; but saw little of the city except for the beach and short visits to a few other sites. This time we were situated right in the downtown area.

San Diego, like much of southern California, is an area of incredible beauty with next to perfect year round temperatures. The Pacific Ocean is powerful and lovely and hundreds of surfers spend hours on surfboards waiting for the right wave.

The San Diego Zoo & Wild Animal Park is a transport to another world where the value of the animal life is in the millions and the value of the plant life surpasses even that.

One can visit La Jolla and view hundreds of birds of many varieties on the cliffs above the ocean, or a stretch of beach where 40 or 50 female seals are in various stages of delivering their offspring & the value of real estate defies belief.

The San Diego harbor is home to many of the elite US naval vessels and Coronado Island, with the old and stately Hotel del Coronado, is a delightful place to spend an afternoon walking the beach shell seeking.

The condominium we lived in was downtown where buildings are in various stages of completion, demolition or rebuilding to accommodate the numbers of people flocking to the area.

It is also a city of great tragedy (to my eyes)...full of homeless people and addicts of all varieties, (alcohol, narcotics and crystal meth...the new kid on the block) competing for handouts.

Back in 2005 we had a picnic on the beach. When I started to clean up our garbage my son said, "No, it will be picked up and used." I'm sure that was so, because the next day that beach area was spotless.

Due to the size of the area and the sheer numbers of people and automobiles, there was at least one accident per day and I was reluctant to travel far from home by myself.

I called the AA number and found that there was only one day time meeting in the downtown area and the woman who answered the phone did not believe I would be comfortable there. However, since it was the only meeting available to me with easy access I went.

I spent the first year of my sobriety at a city meeting in Syracuse, NY and I didn't expect to have a problem at the San Diego downtown meeting.

I didn't! The meeting was in one small room in an old building about 10 blocks from where I was living and was shared with NA on alternated days and hours during the week.

I found a place for myself sitting next to a couple of women. One was an older woman like me, who gave me a book mark with the Serenity Prayer on it. The young man sitting in front of me collected his six year chip from an old timer with 46 years of sobriety. It reminded me of the meeting in Syracuse ... or I could have been at any meeting in Moore County.

The young man also gave me a meeting schedule & a story he had written about sponsorship which had special meaning for me because I grew up on the Columbia River. (You'll understand when you read it...)

Another day and another meeting I sat next to a young woman who asked me how I managed to stay sober in a party town like San Diego. She's right, it is a party town; but I told her "because AA works!".

At one point I worried about whether that meeting would survive ...because the space might be commanded for something more lucrative. I've decided that, hopefully, San Diego will recognize how much it needs AA.

The old timer knew the fate of this youngster's future hung in continuing up the steps and rapids to the final convention. As he pondered it over he thought of the others who helped him when he first started to swim home, his many questions, doubts, fears, uncertainties, and most of all the ever present thought that an old timer once told him about swimming one day at a time.

It seemed like hours went by, but really only a few minutes had passed. He gently tilted his head to the side, looked the youngster in his trusting eyes and said, in a gruff tone, "You see, son, we are supposed to keep

following the ones ahead of us, they know the way there because they are following the ones ahead. But, most of all, we have to remember that the ones that keep swimming through the waters will get to the final convention no matter what happens along the way. The ones who stop will be carried away by the current. So let's save our energy for swimming...you can ask me more questions later. OK?"

"Sure," said the youngster, "I didn't mean to bother you."

"You're not bothering me," said the older salmon, "I swam up here next to you because I saw you were having difficult times over those last rapids and thought you might need some help."

"Thank you", said the youngster.

"My pleasure", said the old timer.

Historical Facts of AA



Jack Alexander's article entitled "Alcoholics Anonymous" in the March, 1941 issue of "The Saturday Evening Post" greatly influenced the growth of AA. At that time the "Post" was one of the country's most popular publications.

Alexander was not an instant believer and it wasn't until he "could feel AA in the very marrow of his bones" that he could write the story that would rock drunks and their families all over the world.

In 1950, just shy of 15 years after the founding of AA, the "Post" published a follow-up article by Alexander entitled "The Drunkard's Best Friend".

Both of these articles can be found on the Internet and will give the reader a crash course on AA's early days.

SPOTLIGHT ON OUR GROUPS



PRIMARY PURPOSE GROUP

AA is often described as a group of alcoholics in ACTION. With this in mind a group of AA members in the Sandhills formed the Primary Purpose Group. We felt that a new group was needed that emphasized ACTION.

An exploratory planning meeting was held in March of 1997 where the basic planning for the Primary Purpose Group was accomplished. We would endeavor to have a job available for everyone that would participate.

In order to achieve this it was decided to establish service committees, as well as the usual officers that are found in most

The service groups. committees established were: Cooperation with the Professional Community, Public Information, Correctional Facilities, Treatment Facilities, Newcomers, Newsletter, Literature and a Program Planning Strangely committee. enough there were exactly the same number of members as jobs, so our job provision goal was met.

The first group meeting was held on June 2, 1997 and it was a huge success. Originally the Monday & Thursday meetings were held at 8 pm...but they now both begin at 7 pm.

On Mondays the group breaks into three smaller groups, after the opening procedures. These include a Closed, pre-selected topic discussion; a Closed Big Book discussion, & a Newcomer meeting that is Open.

On Thursdays there is an Open speaker meeting in which there is a diversity of speakers from inside & outside our community.

The service hours expended by the Primary Purpose Group are impressive. As a rule each month the group members spend:

- 22 hours at Detox.
- 4 hours at Rehab Ctrs.
- 23 hours at Correctional Facilities.

This does not include the countless hours spent with the professional community, public information & all other aspects of the AA service structure.

Each quarter we have a group "outing", which is our excuse to share a good meal and outstanding AA fellowship.

We in the Primary Purpose Group want to help assure that the next person who comes to AA for help gets as good an opportunity to recover as was so freely given to us.

PRIMARY PURPOSE is not just out name, it is our job description!
